



# OF "GRAND CENTRAL", AN 8,500-SQ.M OFFICE BUILDING IN THE HEART OF MARSEILLE

On September 14, Icade's Office Property Investment Division signed an agreement for the off-plan acquisition of an office building covering almost 8,500 sq.m from property developer ARKADEA for €32.4m.





Ideally located a stone's throw from the Old Port of Marseille and close to the Euroméditerranée district, this emblematic building formerly owned and occupied by La Poste was built in 1936 by architect Auguste Bluysen.

ARKADEA has selected Sud Architectes to carry out a major overhaul of the building, with the support of the operational teams of Icade, Icade Promotion and Poste Immo.

"Grand Central" will eventually comprise nearly 8,500 sq.m of office space, including a coworking space and a range of amenities and restaurants, as well as a rooftop terrace covering more than 110 sq.m with panoramic views of the neighbourhood and the Old Port.

The project – to be completed by the end of 2023 – is aiming for the highest environmental certifications (HQE BD Excellent and BREEAM RFO Very Good, WiredScored Gold label).

This acquisition is part of the strategy of Icade's Office Property Investment Division to create an attractive office property portfolio consisting of assets whose location in major cities and environmental quality meet the office needs of companies. The Group has full confidence in its ability to pre-let this building.

The transaction also highlights ARKADEA's ambition to grow across several asset classes and to position itself in the Marseille market by offering high-quality new office space in the city's historic centre.
